Dr. Christensen is currently Emeritus Commissioner of Education a title conferred by the State Board of Education in June, 2008. He was appointed Professor of Leadership in Education for the Graduate Division of Doane College and has designed a leadership program for professionals seeking the endorsement as a superintendent of schools.
