Dear MASA Spring Conference Exhibitor,

The Missouri Association of School Administrators (MASA) and Missouri School Public Relations Association (MOSPRA) Spring Conference will be held in-person on March 24-26, 2021 at The Lodge of Four Seasons, Lake Ozarks, MO. This conference brings together over 500 school superintendents and administrators each year.

Historically, exhibit set-up has been on Wednesday with exhibits open Wednesday afternoon and Thursday morning. We have made some changes to our schedule for 2021 due to COVID-19 in an effort to afford everyone a safe conference.
